

**What is the Interagency Coordinating Council (ICC)?**

- An independent advisory board appointed by the Governor
- A diverse group of early intervention stakeholders from throughout Utah

**What does the ICC do?**

- Holds quarterly public meetings
- Advises and assists Baby Watch Early Intervention
- Advises State agencies regarding the integration of services
- Coordinates with the State Advisory Council on Early Childhood Education and Care and other early learning initiatives
